



# NEW OLD MAPS OF GOOCHLAND COUNTY



Two important Goochland County maps are now available for purchase from the Historical Society. The 1820 map by John Wood is the earliest known map of the County. It was reproduced from the collections of The Library of Virginia. This map shows the location of many of the taverns, ferries, and mills as well as roads that are no longer in use. Reproduced on acid free, heavy weight paper in full color the map measures  $32 \times 20$  inches.

Known as "The Gilmer Map" the second map dates to 1863. It is a detailed map which contains the names of land owners, churches, schools, gold mines, and other sites in the County. Reproduced in full color on acid free, heavy weight paper from the Collections of the Virginia Historical Society who gave the GCHS permission to print and sell this map. It measures 32 x 18 inches.

Sophia Pryor, Eleanor Andrews, Sebastian Volcker, Roselle Scales, Joe Scales, Carol Salmon, Janet Hudepohl, Margaret Walker, Eva and Howard Henley, Gloria and Billy Tucker, Marty MacMillan, and Frances Truett were excellent resources for Mr. Worsham.

The final report is scheduled to be completed in December and a presentation made to the Society and the Board of Supervisors. The Society plans to hold an open meeting where Mr. Worsham will present his results.





#### **COOCHLAND COUNTY HISTORICAL SOCIETY**



The Historical Society is delighted to present the newest acquisition to the artifact collection. Due to the generosity of Margaret Henley, a trunk that belonged to William Miller, 4th Clerk of the Court for Goochland County, is now a part of many treasures the citizens of Goochland have entrusted to the Society.

William Miller served as Clerk of the Court from 1791 until 1846. The present Goochland courthouse was built during his tenure. For many years the Clerk's Office was maintained, and all records kept at William Miller's residence. It is thought that this trunk traveled with Miller as he moved between his home and the courthouse. Some

research indicates that the design of the trunk made it possible to be placed between two bars attached at the rear of a buggy or coach. The top was strapped in and the bottom hung out over the back. It could have also been designed to sit within an attached box or compartment on the carriage and still allow easy access to the contents.

William Miller was the first of several members of the Miller family to hold this position. Narcissus Miller, William's son, was next in line. He is credited with saving all the court records by taking them to the woods to be hidden away during the March on Richmond in the Civil War. With one exception, from 1900–1912, a member of the Miller family served as Clerk of the Court until 1955. "This record would appear to be unparalleled in the history of the Clerks of the Courts of this Commonwealth." (Agee)
